#### <u>Saturday, January 26</u> Off the Record Coffee Talk 10–11:15 a.m.

In a candid conversation facilitated by 21/64, participants will hear two live interviews that reveal both the positive and negative aspects of being a family trustee or CEO and how they make "vision" come alive in their work. There will be plenty of time to ask questions.

### Picturing Your Philanthropic Legacy 11:15 a.m.–noon

Using a set of image cards, participants will articulate their aspirational goals for their philanthropy during this interactive session that will promote self-reflection, expression, and refinement of big ideas in an environment with others on the same path. Participants will leave with a sense of the language they could use to write a personal mission/vision statement and a tool to use to engage others in considering a collective mission and vision for their family philanthropy.
